




**TRUST DEED OF  
SRI BHAGAWAN MAHAVEER EDUCATIONAL TRUST**


THIS DEED OF TRUST made on this 24th day of January Two thousand and two (24-01-2002) by Achalchand Jain S/o Javanmalji, aged 55 years, and Shanthilal P. S/o Perajmalji, aged 52 years, both are residing at Davangere, hereinafter called as the "**FOUNDERS**".


WHEREAS the Founders are desirous of creating a PUBLIC TRUST for Education, Relief to the Poor, Medical Relief and the advancement of other Charitable or general Public Utility not involving the carrying on any activity for profit, and, have donated Rs.2,000/- (Rupees Two thousand only) in cash as initial Endowment which is contributed by Founders equally on the terms and conditions set out hereinbelow:

1. **DECLARATION OF TRUST:** The Founders hereby declare that aforesaid sum of Rs.2000/- initially endowed by them shall exclusively belong to the Trust and form the Corpus and the Founders hereby divests themselves all interest herein and shall in no case revert to the Founders or any of their descendants, relatives, successors, legal heirs or to any other person. The income and funds of the Trust shall be applied towards aims and objects or accumulated for application to the said purposes and such application shall be confined to the aims and objects as set out hereinafter.
2. **NAME OF THE TRUST:** The name of the Trust shall be "SRI BHAGAWAN MAHAVEER EDUCATIONAL TRUST".
3. **OFFICE:** The Principal Office of the Trust shall be located at Davangere and/or such other place(s) as the Trustees may decide from time to time.
4. The benefits of the Trust shall be open to all irrespective of caste, creed, colour, religion or language.

The Trust formed shall be PERPETUAL AND IRREVOCABLE.

AIMS AND OBJECTS OF THE TRUST:

- (i) To establish, maintain and run Educational Institutions for imparting General, Technical, Professional and vocational knowledge.
- (ii) To establish, maintain and run hostels for Boarding and Lodging for students.
- (iii) To establish, maintain and run Libraries and Reading Rooms.
- (iv) To arrange for lectures, study circles, discourses for advancement and enlightenment of knowledge.
- (v) To encourage sportsman and adventurous spirit and promotion of sports and cultural activities.
- (vi) To bring out, encourage and develop the inventive and research faculties of the pupils and teachers and to afford opportunity for research work in Arts, Science and the like-wise.
- (vii) To establish, maintain and run all kinds of Hospitals, Dispensaries, Clinics, Laboratories, Eye Banks, Blood Banks and Health Clubs.
- (viii) To provide humanitarian services in all their form and substance to the needy, poor, oppressed, deserving and who are in dire need of economic, medical and moral upliftment.
- (ix) To grant stipend, scholarships or any other assistance or otherwise to deserving students or scholars.
- (x) To undertake to provide suitable accommodation, Dharmasala for Patients and needy persons, their friends relatives and attendants.
- (xi) To provide preventive and curative services and carry out public utility works.
- (xii) To carry out Anukampa activities and provide food, clothes and shelter to poor and needy persons.
- (xiii) To protect or render assistance to animals and living creatures. It includes establishment of Panjrapole or such other institutions for protection or preservation of animal life and for rendering service to old, decrepit, maimed helpless animals and birds and relieving them from distress.
- (xiv) To initiate and devise suitable measures for collecting the necessary funds.
- (xv) To acquire, hold and/or construct land and buildings for the purposes of the Trust.

- (xvi) To sell, purchase or acquire on lease, mortgage or rent; to mortgage, lease out or exchange immovable properties of the Trust calculated to secure or conduce to the better management of the affairs of the Trust.
- (xvii) To invest the Trust funds suitably and wisely and to incur legitimate expenses.
- (xviii) To take over, help, maintain and administer similar institutions.
- (xix) To borrow, raise loans from any person, Bank or Financial Institutions in such manner as the Trustees deem fit in the interests of Trust.
- (xx) To accept gifts, voluntary contributions from any person, firm, institution or Government and to collect subscription, donation or aid.
- (xxi) To do all necessary things for and incidental or conducive for the attainment of above objects of the Trust.

#### 7. PROPERTIES AND FUNDS:

##### (A) MOVABLE PROPERTY: Movable property shall consist of:

- (i) All donations and voluntary contributions to form the Corpus of the Trust.
- (ii) All gifts, donations and voluntary contributions received in cash or kind that may be made by other charitable or religious institutions or trusts or persons or bodies or sources.
- (iii) All furniture, materials, stores, equipment etc, which may be acquired or received for use.
- (iv) Incomes derived by way of interest/dividend/profits on investments of the Trust funds or otherwise howsoever.
- (v) Income by way of rent from immovable properties and fee and other charges received in respect of the immovable properties of the Trust.
- (vi) Contribution towards membership fee which may be prescribed from time to time.
- (vii) Any other income by way of customary fee and charges.

- (B) IMMOVABLE PROPERTY: The immovable property of the Trust shall consist of all lands, sites, buildings and premises that may be acquired out of the Trust funds for the purpose of carrying out the objects of the Trust by purchase, mortgage, lease, exchange, gift or otherwise whatsoever.

MEMBERS OF THE TRUST: Trustees may enrol any person as member of the Trust irrespective of Caste, Creed, Colour, religion or language and members shall pay such fee as may be prescribed. Life members may be enrolled on payment of the life membership fee as may be prescribed. Only the members/life members of the Trust shall be appointed or elected as Trustees and shall be the office bearers of the Trust. Members/Life Members are entitled to attend the General Body meeting and have right of vote. There shall be no voting by Proxy.

9. **TRUSTEES:** The first Board of Trustees shall consist of the following members who shall be Trustees for life. At no time the number of Trustees shall exceed Twenty-Five. As and when new Trustees are added their term shall be for a period of three years and until new trustees are appointed after the expiry of their term in their place they shall continue as Trustees.

### POWERS AND DUTIES OF THE BOARD OF TRUSTEES:

The Trustees shall manage day to day affairs and administer the affairs of the Trust.

A Trustee who by his conduct as Trustee or in personal capacity adversely reflects on the reputation of the Trust the Board of Trustees may by a resolution passed by two third majority remove him and he shall cease to be a Trustee from the date of resolution.

- (iii) The Trustees shall hold possession of all the properties movable and immovable, which shall hereinafter vest in the Trust and shall have the full powers of control, direction and management of the different activities of the Trust. The Board of Trustees shall have power to receive donations, voluntary contributions and gifts of cash or other property that may be made by others to the Trust and to receive or obtain such other aid or help from any other person or quarter subject to the provisions of these presents.
- (iv) The Board of Trust shall have powers to invest Trust funds in such manner, as they may think fit. The Board shall have further power to use or utilise the Trust funds for carrying out the objects of the Trust and for the purpose of acquisition of properties for the benefit of the Trust.
- (v) The Board of Trustees shall keep accounts and maintain records properly. For the first time accounts shall be closed on 31.3.2002 and thereafter on the 31<sup>st</sup> day of March of every year. The Income and Expenditure account and Balance Sheet shall be prepared every year. The accounts shall be duly audited as per the legal provisions in force from time to time and by a Chartered Accountant as required by Section 12A(b) of the Income-Tax Act, 1961 as amended from time to time.
- (vi) The President shall be the executive head of the Trust. Any Trustee may represent the Trust in all legal proceedings and before the Central and State Government authorities on all required occasions. Trustees shall have power to transact all business of the Trust. Trustees shall call meetings as and when required. President shall preside over the meetings of the Trust Board.
- (vii) The Board of Trustees may open and operate Bank Accounts. All the office bearers of the Trust Board may have power to sign cheques. Cheques shall be signed by at least two members.
- (viii) The Trust Board shall have power to frame rules and bye-laws consistent with the terms of this Trust Deed in order to carry out the objects of the Trust and to vary, change or amend such rules and bye-laws whenever it thinks fit to do so in the best interests of the Trust.
- (ix) The Board of Trustees shall meet periodically as often as may be necessary. It shall review the working of Trust and take such decisions as may be deemed fit.
- (x) Quorum for Board meeting shall be a minimum of thirteen present. Decisions shall be taken on a majority of votes and there shall be no voting by proxy. If and when those present are even in number the President of the meeting shall have a casting vote in addition to his own.
- (xi) The Board of Trustees have power to appoint working committees of such members as it may deem fit from time to time. At least one Trustee shall be appointed in the said committees.

(xii) The Board of Trustees shall have power to appoint Teachers, Tutors, Instructors, Lecturers, Professors, Workers, Servants, Agents, Legal Practitioners, Auditors, Chartered Accountants etc., for carrying out aims and objects of the Trust.

**11. INVESTMENT CLAUSE:**

The funds of the Trust shall be invested in the modes specified under the provisions of Section 13(1) (d) read with Section 11(5) of the Income Tax Act, 1961 as amended from time to time and such other provisions of such law(s) as may be in force from time to time.

**12. AMENDMENT CLAUSE:** No amendments to the Trust Deed/Memorandum of Association/bye-laws/Rules and Regulations shall be made which may prove to be repugnant to the provisions of Section 2(15) 11, 12 and 13 and 80G of the Income Tax Act, 1961, as in force from time to time. Further no amendment shall be carried out without the approval of the Commissioner of Income Tax or such authority/authorities as may be required as per law in force from time to time.

**13.** The funds and income of the Trust shall be solely utilised for the achievement of its objects and no portion of it shall be utilised for payment to the Trustees/members by way of profit, interest, dividend etc.

**14. DISSOLUTION CLAUSE:**

In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees/Members of the Managing Committee/Governing Body. But the same shall be transferred to another Charitable Trust/Institution/Society whose objects are similar to those of this Trust and which enjoys similar recognition under Section 80G of the Income Tax Act, 1961 as amended from time to time.
